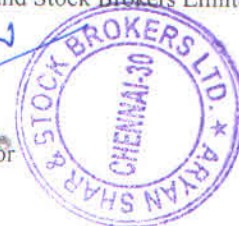

Notes to Financial Results :

- 2 The Company has only one business segment namely Stock Broking. Hence disclosure requirement under Ind AS - 108 Operating segment is not applicable.
- 3 The above financial results have been prepared in accordance with the recognition and measurement principles of Ind AS prescribed under Section 133 of the Companies Act, 2013 read with relevant Rules issued there under and other accounting principles generally accepted in India and SEBI circular dated 5 July 2016.
- 4 No Investor Complaint has been received during the quarter ended 30.06.2021. also there is no outstanding complaint as on 30.06.2021.
- 5 Figures for the quarter ended 31 March 2021 are the balancing figures between audited figures in respect of full financial year and the published year to date unaudited figures upto the third quarter of the respective financial year.
- 6 Covid-19 out break was declared as a global pandemic by World Health Organisation. Stock broking service ,which constitutes the major business of the Company, had been declared as an essential service and accordingly, the Company has been in operation consistently with minimal permitted staff. Accordingly , as of 30 June 2021, based on the facts and circumstances existing as of that date ,the Company does not anticipate any material uncertainties which affects its liquidity position and also ability to continue as a going concern . However , the impact assessment of Covid-19 is a continuing process given the uncertainties associated with its nature and duration.

1.
